

ORDINANCE NO. 852

AN ORDINANCE PROVIDING FOR THE SUPPLYING OF WATER TO METERS TO RESIDENTS OF THE CITY OF SEDAN, KANSAS, AND TO RURAL WATER DISTRICTS, PROVIDING THE RATES CHARGED FOR SUCH WATER; AND PROVIDING FOR THE SUPPLYING OF SEWAGE DISPOSAL SERVICES TO THE RESIDENTS OF THE CITY OF SEDAN, KANSAS, PROVIDING FOR THE RATES CHARGED FOR SUCH SEWAGE DISPOSAL SERVICES AND REVOKING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH:

BE IT ORDAINED BY THE CITY OF SEDAN, KANSAS, TO-WIT:

SECTION I

All consumers of water from the City of Sedan, Kansas, shall be supplied through meters, and said consumer shall pay for the water used by them each month the following rates, fees and charges:

The 1 <sup>st</sup> 2000 gal.	\$17.50
All over 2000 gal.	\$ 6.50 per 1000 gal.

SECTION II

These water rates shall apply to all residents of the City of Sedan, Kansas, and all other customers purchasing water from the City of Sedan, Kansas, including rural water districts, and the rates are uniformly applied to all parties. Effective date for the rate change shall be April 1, 2008.

SECTION III

All users of the City of Sedan sewage disposal system shall pay for such services on a monthly basis which shall be added to the water bills with the rate to be based on the amount of water used by that customer, the rates, fees and charges as follows:

The 1 <sup>st</sup> 2000 gal.	\$ 8.50
All over 2000 gal.	\$ 3.75 per 1000 gal.

SECTION IV

These sewage disposal rates shall apply to all residents of the City of Sedan, Kansas, and all other customers using the City of Sedan sewage disposal system.

SECTION V

The effective date for the rate change for water rates and sewage disposal rates shall be from and after the publication of this ordinance one time in the Sedan Times Star.


SECTION VI

All other ordinances or parts of ordinances relating to sale of water and water usage and sewage disposal rates not in conflict herewith shall remain in full force and effect. All or parts of ordinances in conflict herewith are hereby repealed.


SECTION VII
